DIAMOND INTEREST SDN BHD PERSONAL DATA PROTECTION NOTICE

Diamond Interest Sdn. Bhd. In accordance with the Act:

 8. Unless otherwise specified by us at the time the personal data is collected, it is obligatory that you supply us the personal data requested for by us. Failure to supply us with your personal data may render us unable to carry out the Purposes.
 9. You undertake and warrant to D.I. that your personal data is accurate, complete, not misleading and up-to-date. The onus is on you to update D.I. if your personal data has changed.
 10. D.I. reserves the right to update and amend this Personal Data Notice from time to time. D.I. will notify you of any changes via announcement on D.I.'s website or through other reasonable means of providing notice as D.I. may deem appropriate. Any changes to this Personal Data Notice will be effective immediately upon notice to you.
 11. In the event of any inconsistency between the English, Bahasa Malaysia and Chinese version of this Notice, the English version shall prevail.
